"The Trust decided to transfer all the amounts/income of BBSBEC and BBSBPC except the amalgamated funds to the accounts of the Trust. The Trust appointed the following signatories for operating the various Trust accounts in different banks:

1. Any two signatories out of the three members will operate the bank account in different banks of the Trustt:

- a) President of the Trust
- b) One member of the Trust to be nominated by the President.
- c) Secretary Trust

2) It was decided that the amalgamated funds of BBSBEC and BBSBPC would be operated jointly as per the instructions given below:

a) Secretary Trust and Principal BBSBEC will jointly operate the amalgamated funds accounts of BBSBEC, Fatehgarh Sahib.

b) Secretary Trust and Principal will jointly operate the amalgamated fund accounts of BBSBPC, Fatehgarh Sahib.

However, to manage the work of the colleges efficiently and smoothly the Trust authorized the Principal of BBSBEC and the Principal of BBSBPC, Fatehgarh Sahib to make payments up to Rs.25000/- as was done earlier under their individual signatures. In such cases there will be only one signatory for payment up to Rs.25000/-. However, the bills for more than Rs.15000/- will be countersigned by the Secretary of the Trust. The Trust directed the Principal, BBSBEC, Fatehgarh Sahib and the Principal, BBSBPC, Fatehgarh Sahib to transfer the amounts to the Trust account(s) at the earliest before the next Trust meeting."
