- The house appreciated that HoD's/BOS members had reviewed changes in content and conduct of any subject in line with the technological advancements.
- **2.3 Transparency in academics is to be implemented.** Delivery of curriculum must be formalized, recorded and periodically reviewed in accordance to the curriculum plan of the institution.
- 2.4 To consider and approve the format of code of conduct for students: Students must be made aware about code of conduct. A proper document for the same should be given to the students.
- 2.5 To report of Implementation of examination reforms in accordance with AICTE regulations.

 Blooms Taxonomy to be implemented in all the departments, CO attainment is to be done for each course.
- 2.6 A committee headed by the Dean Exams/Dy. Dean Exams and all HODs (members) will coordinate with the university and check for any curriculum change where as new courses may be started in the CSE and ME departments.
- **2.7 IQAC is interested in increasing Skill Development Courses** running under PMKVY scheme in the college. At present, 4 courses are running and HoDs may identify more courses, which can be started within existing resources in their respective departments. Every department should identify one or two such course(s).
- 2.8 It has been decided that at least one FDP/STC/Workshop should be conducted on regular basis.
- 2.9 There is a need to strengthen Mentor-mentee system in the institute.
- 2.10 Need to strengthen the internal quality system through academic and administrative audit.
- 2.11 Institute needs to apply for the NIRF rating and NAAC accreditation by the due date.
- 2.12 There is a need to strengthen social responsibilities of the institute by promoting technical and vocational education in the region.
- 2.13 To discuss any other point with the permission of the chair:
 - S. Jatinder Singh Manchanda proposed that students must be trained for soft skill and aptitude aspects for their enhanced employability aspects.
