- PMKVY Programs: 19 programs are already approved by AICTE under PMKVY programs. Institute need to start more courses.
- Orientation Program of newly admitted students as per the guidelines of AICTE: On the
 reporting of all newly admitted students, a one-day orientation program must be organized by
 HOD (AS) in coordination with Dean Academics. HOD must ensure that these students firstly
 come to the college and then settle down academically. Special classes will be organized for these
 students so that they can cope with the syllabus before 1st MST.
- NBA Accreditation: Institute's present NBA accreditation is up to June 2020. Hence departments need to be re-accredited.
- Student's activities: Need to enhance extension activities to promote happiness and learning of students
- Curriculum Delivery: Effectiveness of curriculum delivery in accordance with university norms to be maintained at all levels in the institute.
- Online PEP: There is a need of providing aptitude and soft skill training through online approach for enhancing flexibility in time and content.
- Green Audit: To put a step towards Green Initiative, Institute need to undertake green and energy audit of the institute.
- Online Grievance Redressal System: AICTE made it compulsory for all institutions to create
 online grievance redressal system for staff and students. The process for procuring the software
 is going on and the system has to be functional in college at earliest. The faculty need to aware
 with the software, that how it would be used. The students make their grievances, if any, online
 on this system and it will be the responsibility of the institute to solve the grievances at the
 earliest because a monthly report will go to AICTE.
